### EVENT SPECIFICATIONS:

- NO generators allowed!
- Vendor must supply their own electrical cords.
- Electrical cord covers are required by the Parks Department.
- You must be able to comply with the New Mexico Department of Health standards. Please contact 575-388-1934 or 3082 32nd Street Bypass, Suite D, Silver City, NM 88061 for a food service application which must be completed and returned to NMDH for your temporary license. Without this license you will not be permitted to setup.
- Supply trailers will be located in the 12th St. parking lot, adjacent to the Food Court.  
**NO EXCEPTIONS.**
- Water availability is limited. A self-contained system is optimum.
- No city-vending permit is required. You are responsible to collect and pay applicable taxes.
- Set up is **Friday, May 27, beginning at 10 AM. NO EARLY BIRDS.**
- Exhibitors must contact vendor coordinator to schedule set-up time. Contact info: [bluesvendor@mimbresarts.org](mailto:bluesvendor@mimbresarts.org), 214-406-5089 (cell), or office 575-538-2505.
- Reselling (subletting) your assigned booth space is NOT permitted.
- **Booth break down is NOT permitted until 7:00 PM on Sunday, May 29, 2011**, except for emergencies and exhibitors who are 95% sold-out. Vendor booths must be completely off the site by 9 pm, Sunday, May 29, 2011.
- Dangerously hot exhibit lighting (such as halogen) and combustible or explosive materials; items stacked at heights which could possibly fall; items displayed low or at ground level that could cause tripping; extremely sharp items; or any items of potential danger to the public, are not allowed on the grounds. Exposed grills, smokers, etc. must have a barrier to keep the public from potential burns.
- Per city ordinance no pets or wheeled vehicles allowed other than service animals and wheelchairs. **NO EXCEPTIONS.**
- Security is provided Friday and Saturday evenings from 8 PM – 8 AM. Vendor agrees to indemnify and hold harmless MRAC for any loss or damage to property.
- Vendor parking will be available in the reserved lot on 12<sup>th</sup> St. **THE BANK DRIVE-THRU MUST BE LEFT UNOBSTRUCTED.** Parking is on a space-available basis; if lots are full, vendors must secure legal parking elsewhere. **ONE PARKING PASS PER VENDOR.**
- Parking passes will be distributed at check-in. Please locate **Julie Minicucci, Vendor Coordinator**, in Gough Park, upon your arrival to escort you to your designated space. Site layout is pre-planned and spaces are pre-designated at our discretion.
