**TAKE DOWN:** FRIDAY, DECEMBER 17TH between 9 AM & 4 PM

Pieces can not be picked up prior to this date–no exceptions

### MRAC Gallery Guidelines

1. The Mimbres Region Arts Council (MRAC) is the curator for all applicable sites. The MRAC will determine the contact person for each gallery. Shows will be chosen on "business appropriate" art and will predominately be open to local artists or local artists in group shows. Group shows are encouraged. Ideas should be presented to the Visual Arts Committee (VAC). This jury committee is comprised of 3 or more artists. The VAC will hang each show. The VAC reserves the right not to hang work that is deemed inappropriate, is not "ready to hang" or if space is limited. **Each show will hang for approximately 3 months.**
2. **Artists hanging in the MRAC Gallery must be a member of MRAC.** Individual annual membership is \$25.00. A business membership, for 5 or more artists, is \$125.00. Additionally, there is a gallery rental fee to help cover the costs of the opening reception and publicity. The fee for up to 3 artists is \$40, for a Group Show, \$80. If an entry fee is charged for a show, then the rental fee is waived. Entry fees (if applicable) are non-refundable.
3. **All work must be for sale.** Artists should maintain a consistent retail price regardless of where they exhibit or how much commission is taken. Commissions on work sold in the gallery will be 25%, and will be deducted from the artist's payment. Final checks will be mailed out at the end of the show. MRAC will collect 7.25% sales tax on each piece sold and remit this to the artist who is responsible for paying appropriate taxes to the State of New Mexico.
4. **Art should be ready to hang.** This means that work must be framed with hanging-wires and frames are attached. The artist needs to identify each piece with artist's name and title of art on the back of each piece. An inventory sheet from each artist will also accompany the work upon delivery. This will contain the artist's name, title, medium used, and price of artwork. Pedestals, display items, and/or easels are the artist's responsibility.
5. To hold a piece of art, the customer must pay (at least) a 25% non-refundable deposit. **All art sales are final.**
6. The artist is responsible for getting publicity info (Picture & Bio) to MRAC **six (6) weeks** prior to show start. This will be used for press releases, web, and promotion. Artists showing at other galleries should work out agreements with their respective galleries concerning exhibiting their work in a MRAC sponsored gallery.
